Prices for the 2008 shooting year will remain the same and can be found on our web site (www.shootkta.com) Payments and questions may be directed to Sandra McAllister.

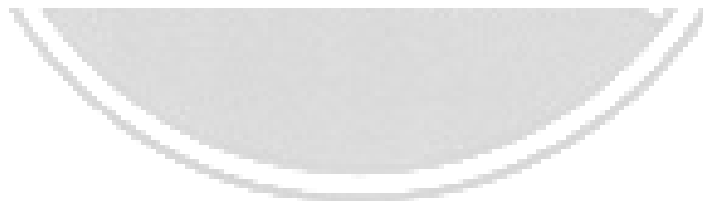
Please include your payment for the year lease if due. If you have a copy of your last receipt we would appreciate a copy.
